Walk-In Counseling Center was founded in 1969 in response to the unmet need for accessible mental health services in the Twin Cities. Since then Walk-In volunteers (master degree and PhD clinicians) have provided free counseling to tens of thousands of people - and indirectly countless family members and friends - by helping them address intense mental health and emotional issues, and interpersonal concerns. In addition to helping people, we have improved the quality of mental health services in the community through our training and consultation to counselors, social workers and other helping professionals and organizations. In 2016, 180 volunteers provided 17,907 hours of service to 2,276 clients in 6224 sessions. The services were valued at \$1,107,815
